

Cost Control

In order to minimize change orders and maximize the savings for the client, RCG's standard cost control procedure is as follows:

- Provide a full and detailed in house take-off of the project
- Ensure that all sub-contractors attend a walk through
- Ensure that all sub-contractors that bid are qualified to complete their respective scopes
- Clearly define the scope of work early on and pre-purchase all long-lead items
- Constant review of bid documents during construction so that potential problems are identified and dealt with early to ensure we meet budget and schedule constraints
- Utilize "just in time" delivery system to minimize downtime and on-site stock piling
- Establish and maintain excellent relationships with local building & zoning departments to avoid delays and additional costs

Quality Assurance

Measures that RCG undertakes to maintain quality control include:



- Coordinate closely with the architect, designer and engineer
- Stay informed of building management procedures, rules and regulations
- Identify long-lead items and order early
- Select subcontractors who have experience with similar projects and, if necessary, obtain references from these subcontractors
- Create and follow a realistic and detailed schedule
- Maintain logs and records of RFIs, submittals and daily construction reports
- Coordinate with all relevant testing and inspection agencies to maintain strict controls during construction

Our Commitment to **Safety**


